Parks and Rec Gastropub Pavilion

Thank you for choosing Parks and Rec for your event. Our private Pavilion will hold up to 64 guests and includes a full service bar along with 2 big screen televisions.

Deposits/Method of Payment

In order to confirm your reservation, a signed contract along with a non-refundable deposit of \$250 will be required at the time of booking. We take all major credit cards, debit, and cash.

Pricing and Gratuity

All prices quoted are plus 13% taxes, and 18% gratuity fee.

Guest Count

A total for your guest count is required one week prior to your event. If the actual number exceeds the guaranteed number, every effort will be made to accommodate you. You will be charged for the guaranteed number or the actual number served, whichever is greater.

Exclusivity

Parks and Rec retains the exclusive rights to provide all food and beverage for your event. Guests are not permitted to bring any food or beverage items with the exception of CAKE or homemade desserts. We ask that you provide a knife and plastic plates and forks for your own desserts. We do offer a \$2 cake cutting fee where we will cut and plate the cake for you. This service also comes with vanilla ice cream for each serving.

Decorations, Flowers and Setup

If you plan to provide centre pieces, party favours, flowers or other decorations, please contact our management team to arrange a time for delivery, setup and tear down.

Hall Rental

A rental fee of \$250 is required. The rental fee is waived if your food bill exceeds \$500. The rental fee includes linen, use of our stereo system, two large screen televisions, and full service staff.

Liability

Parks and Rec is NOT responsible for lost, stolen, or damaged items. Any damages incurred to the restaurant will be charged to the final invoice.

Dietary Concerns

Please inform our management team if you have any dietary concerns and we will do our best to accommodate you.

Alcohol Service

All alcohol must be purchased at the restaurant as per AGCO regulations. NO outside alcohol can be brought on our premises. Bartenders and servers are fully certified as per Smart Serve regulations and supplied by Parks and Rec. Our staff reserves the right to enforce Smart Serve regulations, they can, and will, suspend alcohol service to patrons who are deemed to be in violations of these standards.

Terms and Conditions for Parks and Rec Pavilion

The reserved date will not be held until the contract is signed and the \$250 deposit has been received. Payment in full is due the date of the event. Banquet packages are current and subject to change.

Guaranteed number of guests is required one week in advance. This is the minimum number for which you will be charged.

The "Renter", guests and invitees of the Renter will abide by the rules and regulations of Parks and Rec, including all requirements of the Liquor Control Act.

The Renter will be responsible for and indemnify Parks and Rec Gastropub from any and all damages incurred by the renter and guests of the renter. Parks and Rec Gastropub is not responsible for lost or stolen items.
